# Odor Remediation Project – SY009

- Phase I, \$9.6 Million – Screen & Grit Bldg HVAC and Odor Control including Ludlow St PS Odor Control
  - Operational, Work Essentially Complete
  - In Close-out
- Phase II, \$9.8 Million – HVAC System Upgrades to Blower, Admin Bldgs. & New boilers
  - Operational, Work Essentially Complete
  - In Close-out
- Phase III, \$7.3 Million – Odor Control for Primary Access Bldg & South Pumping Station, HVAC systems in several other area's and buildings
  - Scheduled Completion May 2018
  - Approximately 60% Complete

- Emergency Generator Replacement

New Electrical Switchgear and new Emergency Generator

- Anaerobic Digester Gas Fueled Generator

New ADG Fueled Generator to Generate Electricity for Plant Use

- Operational, Work Essentially Complete
- In Close-out
- Operational, Engine is Running Supplying Electricity
- In Close-out

# Other Construction Projects

- Sandy Repair Phase I

Replacement of motors, wiring and control panels for process pumps located in the basement.

- Sandy Repair Phase II-2

Repair and rewire site lighting

Replace motors and wiring for tank collection systems

- 100% Complete

- Construction Started July 2016

- Approximately 40% Complete

# Other Construction Projects

- Sandy Repair Phase II-3

Replace and rewire interior lighting. Install new Potassium Permanganate system

- Sandy Repair Phase III

New motors, wiring, and controls for Basement Sump system and Primary Digester Process

- Construction Started May 2017

- Approximately 40% Complete

- Construction Started June 2016

- Approximately 65% Complete

# Other Construction Projects

- DAF Upgrade

Replacement of DAF Thickeners with new Gravity Belt Thickeners and Related Equipment

- Engine Replacement Project

Multi Phase Project to Replace Engine driven Blowers with Turbo Blowers and ADG Engines and various other upgrades to Secondary System

- Construction started December 2017
- Approximately 4% Complete
- Phase II design at 100%
- Phase III design at 100%
- Phases II & III Construction Bids Due May 2018
- Phase IV design at 30%

Refurbishment of Grit Removal System With Redundancy Additions

- Sluice Gate Project

Replacement of Sluice Gates in Secondary System

- Secondary Treatment Area Upgrades

Refurbishment of Various Small Systems in Secondary Area

- Design 90% Complete

- Design 90% complete. Water Audit scheduled for Spring 2018


